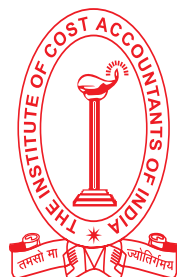

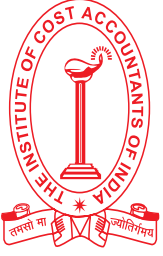

7.2 Financial Commentary

1. Sustained Income Growth — ₹644 Lakhs, Up 3.21%

Total income grew from ₹624L to ₹644L, continuing a multi-year upward trajectory - demonstrating the region's financial resilience.

2. Healthy Surplus of ₹260 Lakhs

Despite significantly higher programme spend, SIRC delivered a net surplus of ₹260L. The year-on-year dip from ₹312L reflects a conscious investment in member value.

3. Fixed Deposits Cross ₹33 Crore — Reserves at an All-Time High

Fds grew by ₹222L to ₹3,316L, compounding steadily over four years. This is the institution's financial backbone and a testament to prudent treasury management.

4. Total Assets Stand at ₹36 Crore — Up ₹2.6 Crore in One Year

The Regional Council Fund grew by ₹2.60 Crore to ₹35.90 Crore, reflecting consistent wealth creation for the institution year after year.

5. Strategic Capex: Lift Installed at CMA Bhawan — ₹18.95 Lakhs

A post-balance-sheet capital addition that signals SIRC's commitment to modernising its infrastructure — enhancing accessibility and the member experience at the regional headquarters.

9.1 Campus Placement Programme (22.04.2025 to 24.04.2025):

The Career Counselling & Placement Committee in association with SIRC organized the CMA Campus Placement Programme for qualified Cost Accountants from the December 2024 term. The event was held from April 22nd to April 24th, 2025, at Hotel Ambassador Pallava, Chennai, and saw participation from a range of leading Public Sector Units (PSUs), Multinational Corporations (MNCs), and Private Companies. Around 600 candidates participated in the placement drive, approximately 100 candidates selected for placement. Prior to the placement programme, a Pre-Placement Orientation Programme was conducted in March 2025 in 2 batches to equip candidates with essential interview skills and help them secure high-paying positions with leading organizations.



9.2 Industry Oriented Training Programme (01.04.2025 to 11.04.2025)

SIRC conducted a 10-day Industry Oriented Training Programme (IOTP) from 1st to 11th April 2025 for Final Course students appearing in the June 2025 Examination. The programme witnessed enthusiastic participation from around 275 students and was designed to bridge the gap between academic learning and industry expectations. Expert-led sessions covered key areas such as Risk Management, MIS Reporting, Working Capital Management, Project Financing, Cost & Other Audits, Direct and Indirect Taxation, Digital Financial Services, Company Formation, Contract Management, Communication Skills, Interview Skills, Group Discussions, and Soft Skills. The programme equipped students with practical insights, professional competencies, and industry readiness to excel in their careers.



9.3 CMA AI Pravesh: Deep Dive into AI & Machine Learning (April 2025)

The ICAI – AI Strategy & Capacity Building Committee conducted CMA AI Pravesh in April 2025 through online and in-person sessions at SIRC. The programme provided participants with practical exposure to Artificial Intelligence and Machine Learning through expert-led sessions, real-world applications, and interactive discussions. It enhanced participants' understanding of emerging technologies and their relevance to the evolving role of Cost and Management Accountants.



9.4 Workshop on Costing in Service Sector (10.05.2025)

On 10th May 2025, SIRC of ICAI organized a One-Day Workshop on “Costing in Service Sector” at CMA Bhawan, Chennai, on the theme “Strengthening Costing Frameworks: Solutions for Industry-Specific Challenges.” The programme featured three technical sessions, including a panel discussion with eminent CMA professionals, providing practical insights into contemporary costing practices in the service sector. The workshop was inaugurated by CMA P. Raju Iyer, Former President – ICAI, and was attended by CMA T.C.A. Srinivasa Prasad, Vice President – ICAI, along with SIRC office bearers and members. The programme provided 4 CPE hours and served as a valuable platform for professional learning and knowledge sharing.



9.5 Taxation Summit 2025: Shaping the Future of Taxation (17.05.2025)

On 17th May 2025, the Corporate Training Committee of SIRC of ICAI organized a “**Taxation Summit: Shaping the Future**” at CMA Bhawan, Chennai. The summit featured expert sessions on recent developments in direct and indirect taxation, including updates on the Income Tax Bill 2025 and TDS/TCS provisions under GST. The programme was graced by CMA Pooja Kulkarni, IAS, ACMA, Special Secretary to Government and CEO, Tamil Nadu Infrastructure Development Board (TIDB), as Chief Guest, along with distinguished dignitaries from ICAI and SIRC. SIRC Management is responsible for preparation and fair presentation of the financial statements in accordance with The Cost Accountants Act, 1959, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the entity's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. 5. Evaluate the overall presentation, structure and content of the financial statements, including the disclosures and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

Materiality is the magnitude of misstatements in the financial statements that, individually or in aggregate, make it probable that the economic decisions of a reasonably knowledgeable user of the financial statements may be influenced. We consider quantitative materiality and qualitative factors in:

- i. planning the scope of our audit work and in evaluating the results of our work; and
- ii. to evaluate the effect of any identified misstatements in the financial statements.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

Report on Other Regulatory Requirements

- We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit.
- In our opinion, proper books of account as required by The Cost Accountants Act, 1959 have been kept by SIRC so far as it appears from our examination of those books.
- The Balance Sheet, Income and Expenditure account, and Cash Flow statement dealt with by this report are in agreement with the books of account.
- In our opinion, the Balance Sheet, Income and Expenditure account and Cash Flow statement dealt with by this report are prepared in accordance with the applicable Accounting Standards issued by the Institute of Chartered Accountants of India and guidelines issued by The Institute of Cost Accountants of India.

NOTE - 23**I. ACCOUNTING POLICIES****1. Basis for preparation of Financial Statements:**

The Financial Statements are prepared under the historical cost convention, the Generally Accepted Accounting Principles (GAAP) in India, the applicable Accounting Standards, the relevant provisions of The Cost Accountants Act, 1959, as amended and are on accrual basis unless otherwise stated.

2. Revenue Recognition

The Institute recognizes significant items of income on the following basis:-

- a) Tuition and other Fees
Revenue in respect of Postal and Oral Tuition Fees are recognized as and when the student is enrolled.
- b) Commission on Sale of Publications is recognised on completion of sale
- c) Revenue from Programme and Research Fee is recognized as and when such activity is undertaken
- d) Income from interest for the year due on deposits with banks is recognized on accrual basis taking into account the amount of Fixed deposits and the applicable rate.
- e) Grants from HQ are recognised on the receipt of confirmation from Head Quarters.
- f) All other incomes are recognised on a receipt basis

3. Property, Plant and Equipment

Property, Plant and Equipment are stated at cost less accumulated depreciation. Cost comprises the purchase price and any cost, attributable to bringing the asset to its working condition for its intended use. Assets under creation are shown as capital work-in-progress.

4. Depreciation/Amortization:

Depreciation on Property, plant and Equipment is provided on written - down value method at the rates prescribed under Income Tax Act, 1961

5. Investments:

Investments in Fixed Deposits are stated at cost.

6. Inventory

Materials procured from Head Office and others are valued at Cost or Net Realizable Value, which is lower.

7. Expenditure

The expenditure is recognised on accrual basis

8. Employee Benefit

- a) The short term employee benefit is recognised when claimed during the period. Unclaimed amount is provided for.
- b) Contributions to Provident Fund, Family Pension Fund and Deposit Linked Insurance are accounted for on accrual basis and the liability in respect of Gratuity and Leave Encashment is recognised on ad hoc basis this year, since yearly premium payable to LIC on the basis of actuarial valuation is not yet received by HQ.

9. Use of Estimates

The preparation of the financial statements requires the Management to make estimates and assumptions considered in the reported amounts of assets and liabilities and the reported income and expenses of the year. The Management believes that the estimates used in preparation of the financial statements are prudent and reasonable. Actual results could differ from the estimates and the differences between the actual results and the estimates are recognized in the periods in which the results are known/ materialized.

10. Accounting for Provisions, Contingent Liabilities and Contingent Assets:

(I) A provision is recognized:-

- (a) when there is present obligation as a result of past event;
- (b) it is probable that an outflow of resources embodying economic benefit will be required to settle the obligation and
- (c) a reliable estimate can be made of the amount of obligation.

(II) No provision is recognized for:

- (a) any possible obligation that arises from past events and the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of SIRC
- (b) any present obligation that arises from past events but is not recognized because it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation or a reliable estimate of the amount of obligation cannot be made.

Such obligations are disclosed as Contingent Liabilities. These are assessed at regular intervals and only that part of the obligation for which an outflow of resources embodying economic benefits is probable, is provided for except in extremely rare circumstances where no reliable estimate can be made.

11. Impairment of Assets:

At the Balance Sheet date, impaired assets, if any, are identified and necessary provision as required is made.

12. Prior Period Income / Expenditure

Prior period items which arise in the current period as a result of errors or omissions in the preparation of financial statements in one or more prior periods are separately disclosed in the Income & Expenditure Account

13. All other accounting policies are consistent with the generally accepted policies.

II. NOTES ON ACCOUNTS

1. Fixed deposits to the tune of Rs.12,87,617/- (PY - Rs.12,88,396) have been earmarked towards closing balances of Endowment/Memorial Funds, Building Development Fund etc.,
2. The Annual Accounts for the Financial year 2025-26 with the previous year has been prepared in the format prescribed by the Head Quarters.
3. Library Deposit remaining unclaimed beyond 3 years amounting to Rs.2,400(PY- Rs.Nil/-) has been transferred to Regional Council Fund. In the event of any refund arising in future, it will be paid from the fund.
4. Input Tax Credit in respect of GST is availed only in respect of expenditure incurred pertaining to paid programmes conducted by SIRC. In all other cases SIRC accounts expenditure inclusive of GST.
5. Previous year figures have been regrouped wherever necessary.
